SELECT BOARD APPOINTMENT PROCESS

- The Chair calls on Board members to please offer nominations or states “Nominations for the committee are now in order.”
- Board members offer names they wish to nominate, with the Chair announcing each nomination as it is heard. No one can nominate more than one person to appointment on the committee until every other member has had the opportunity to nominate a candidate. The nomination of more than one person at a time by a single member can be entertained only by unanimous consent.
- If there are the same number of applications as open seats, and all members meet eligibility requirements, then a vote is not needed but the Board can vote to confirm appointments.
- Once all nominations are provided, a request by a member must be made for “nominations to cease”. If there are more nominees than the required number of committee members, then, once nominations have ceased, and there are no further nominations, the Chair repeats all of the names in the order in which they were nominated to be voted on. In same order as they were nominated, the Chair will call for a vote and appointment of each nominee; one at a time until the proper number have been elected and appointed to meet the seat requirements.
